PROCEDURE OWN COMPETITION  
THE OCCUPATION OF TEACHING  
RESEARCH AND HOLIDAYS  
THE FACULTY OF ENVIRONMENTAL PROTECTION

**Article 1.** The University of Oradea (UO), teaching positions or research positions dealing, indefinite, only through *public competition*, according to Law. 1/2011, the H.G. No. 457 approving the Methodology - frame competition for teaching and research positions in higher education (published in the Official Gazette, Part I, no. 371/26.05.2011) and the present proceedings hereinafter own procedure.

**Article 2.** (1) In order to enter in the contest for a teaching and research position candidate prepares a dossier containing the following documents:

- a) the application for the contest, registered in the University of Oradea signed by the candidate accompanied by an affidavit concerning the veracity of the information presented in the file - pattern;
- b) a proposal for the development of academic career, both in terms of teaching as well as in terms of scientific research, proposal written by the candidate hold a maximum of 10 pages and is one of the main criteria for the candidates.
- c) curriculum vitae of the candidate in written and electronic format according to the University of Oradea methodologies for teaching positions;
- d) list of candidate papers printed and electronic format according to the University of Oradea methodologies for teaching positions;
- e) sheet verifying the fulfillment of standards in the contest and / or post employment minimum standards in force field;
- f) copy of the diploma of doctor and if the original doctor's degree was obtained abroad, certificate of recognition or its equivalence to the Romanian state;
- g) a summary of the thesis or, where appropriate, habilitation thesis on one page maximum in Romanian and English;
- h) the applicant's affidavit indicating incompatibilities in the Law nr.1/2011 (National Education Law that would be for winning the competition or lack of such incompatibility;
- i) copies of other certificates attesting to the applicant's studies: high school diploma or certificate of recognition degree or certificate of recognition, master's degree or certificate of recognition - will present original documents for compliance;

- j) transcripts, supplemental school diploma or statements issued for each cycle - will present original documents for compliance;
  - k) Copy of identity card or passport or other identity document issued in an equivalent purpose identity card or passport;
  - l) If the candidate has changed his name, copies of documents evidencing the change of name - marriage certificate or proof of name change;
  - m) medical certificate attesting that is able to carry out teaching;
  - n) more than 10 publications, patents or other work of the candidate, in electronic format, selected by him and considered to be most relevant for their professional achievements.
- (2) If the work is not available electronically or can not be scanned (musical or theatrical performances, paintings etc.) Will make recordings or photos.
- (3) On application files are attached and a CD / DVD or other electronic format, the entire contents of scanned for transmission to the competition commission.

**Article 3.** This procedure shall enter into force on the date of approval of the University of Oradea methodologies for teaching positions in the University Senate.
