**OWN CONTEST PROCEDURE  
A  
FACULTY OF CONSTRUCTION,  
CADASTRE AND ARCHITECTURE  
FOR EMPLOYMENT  
TEACHING AND VACANCY RESEARCH POSTS**

Valid since academic year 2018-2019

In the Faculty of Construction, Cadastre and Architecture, teaching or vacancy research posts are for indefinite duration only by **public competition**, according to:

- Law No. 1/2011,
- H.G. No. 457 on the approval of the framework methodology of the competition for the occupation of teaching posts and vacancies in Higher education (published in M.O. part I, No. 371/26.05.2011)
- Its own competition methodology for the indefinite occupation of teaching and research vacancies in the University of Oradea, approved in the University Senate of Oradea at 26.11.2018
- Provisions of the OMENCS No. 6129 of 2016 on minimum standards for accepting participation in competitions for the conferment of higher education and professional research and development degrees;
- Of this procedure, hereinafter referred to as the **Own procedure of the Faculty of Construction, Cadastre and Architecture**;
- Other normative acts in force on the date of support of competitions.

The competition for the occupation of teaching and research vacancies for an indefinite period of the Faculty of Construction, Cadastre and Architecture is carried out in accordance with this procedure and with the "*Own methodology of competition for the occupation of teaching and vacancy research posts in the University of Oradea*" adopted by the decision of the University Senate Annex 11/26.11.2018 regarding the updating of Annex 3 to the Charter of the University of Oradea.

The competition methodology of the University of Oradea is available on the website of the University of Oradea [www.uoradea.ro](http://www.uoradea.ro).

All information relating to the contest will be published on the webpage of the University of Oradea, [www.uoradea.ro](http://www.uoradea.ro), button contests on posts.

Given the specifics and requirements of each field, the Faculty of Construction, Cadastre and Architecture develops its own competition procedure which is a complement to the "*Own methodology of competition for the occupation of teaching and vacancy research posts in the University of Oradea*" adopted by Senatului academic judgment in annex 11/26.11.2018 of the University of Oradea.

The general aspects, the entry to the competition and the contest, as well as the annexes, are found in the "*Own methodology of competition for the occupation of teaching and vacancy research positions in the University of Oradea*". Exception are article 9, annexes No 3 and No. 6,

whose modifications and format are presented in the own procedure of the Faculty of Construction, Cadastre and Architecture.

**Art. 9**

**(1)** The conditions for enrolling in the competition for the occupation of a teaching function are those provided by the present article regarding the fields of civil engineering, geodetic engineering and architecture, specific minimum standards will be applied.

**(2)** For the position of university assistant, cumulative requirements are required:

- a) The holding of the PhD Diploma in the field of the post taken in the contest or in close areas;
- b) Publication of a minimum of 3 scientific papers ( in extenso or in summary) in a reference magazine/volume Conference for the field of fasting indexed in an international database [BDI], quoted or indexed magazines and Thomson Reuters-Category A-cnscis; ISI Proceedings.
- c) Promotion of three competition samples, on the assessment of specialized knowledge in direct accordance with the disciplines of the post taken in the contest:
  - 1) *Practical sample* (support of a seminar or practical work in front of students and in the presence of the competition Committee);
  - 2) *Oral sample*.
  - 3) *Written sample*

The result of the competition samples is appreciated by each member of the Commission by grades 1 to 10, the note of the sample representing their arithmetic average.

**(3)** For the position of university lecturer / head of works, cumulative requirements are required:

- a) The holding of the PhD Diploma in the field of the post taken in the contest or in close areas;
- b) Publication of a minimum of 5 works (in extenso or in summary) in a reference magazine/volume Conference for the field of fasting indexed in an international database [BDI], quoted or indexed magazines SE Thomson Reuters-category A-CNCSIS; ISI Proceedings.
- c) Publication of at least one specialty book in any of the subjects of the post under the aegis of nationally or internationally recognised publishing houses.
- d) The elaboration, at least in electronic form, of a specialised teaching material for the use of students in the field of the post taken to the competition;

**(4)**For the position of senior lecturer cumulative requirements are required:

A) The holding of the PhD Diploma in the field of the post taken in the competition or in close areas;

b) The fulfilment of the minimum national standards for the employment of didactic posts, specific to the teaching function of the senior lecturer, related to the field of the post taken to the competition, approved by order of the minister, according to art. 219, para. (1), lit. A) of law No. 1/2011;

**(5)** For the position of university professor cumulative requirements are required:

A) The holding of the PhD Diploma in the field of the post taken in the competition or in close areas;

b) Holding the quality of doctoral leader;

c) The fulfilment of the minimum national standards for the employment of teaching positions, specific to the teaching function of the university professor, related to the field of the post, approved by order of the minister, according to art. 219, para. (1), lit. A) of law No. 1/2011;
