I. GENERAL ASPECTS

Art. 1. In the University of Oradea (UO) and in the The Faculty Of History, International Relations, Political Sciences And Communication Sciences (IRISPSC), the vacant didactic or research positions are filled *on indefinite period*, only through *public competition* conforming with:

- Law no. 1/2011, a G. D. no. 457/2011 modified by G. D. no. 36/2013 on the approval of the Competition Framework Methodology for filling vacant teaching and research posts in higher education (published in O. G. part I, no. 88/11.02.2013);
- Decision no. 883/2018 on amending and supplementing the Contest Framework Methodology for filling vacant teaching and research positions in higher education (published in O. G. part I, no. 967/15.11.2018);
- Emergency Ordinance no. 96/08.12.2016 for the amendment and completion of some normative acts in the fields of education, research, professional training and health (published in the Official Gazette of Romania, part I, no. 1009/15.12.2016,);

- Order of the Minister of National Education and Scientific Research no. 6.129 / 2016 regarding the approval of the minimum necessary and obligatory standards for conferring didactic titles in higher education, professional research and development degrees, the quality of doctoral supervisor and the habilitation certificate (Commission 31 History and Cultural Studies, respectively Commission 25 - Sociology, political and administrative sciences), of 20.12.2016;

- The specific standards regarding the external evaluation of the academic quality for the study programs in the fields of bachelor and master related to the specialized commission no. 2 Humanities and Theology, respectively specialized commission no. 4 Social, political and communication sciences approved by the ARACIS Council in 2017;
- Own competition methodology for filling indefinite teaching and research positions in the University of Oradea, approved in the Senate of the University of Oradea on November 26, 2018;
- This Procedure for filling vacancies by competition, for an indefinite period;
- other normative acts in force at the date of the competitions.

Art. 2. (1) *The competition for the indefinite filling* of a teaching or research position is organized *only if the position is vacant.*

(2) A position is considered vacant if it is provided as such in the list of positions, prepared annually to the three departments (History, International Relations and European Studies; Political Science and Communication Sciences), at the Faculty IRISPSC or if it is vacant during the academic year.

(3) Vacations are made in one of the following ways:

a) termination of the employment contract, by retirement, death, resignation, dismissal or by another way of termination of the employment contract, according to the law;

(4) Teaching and research positions cannot be put out to competition by transforming an occupied position into a higher-ranking position.

Art. 3. (1) The University of Oradea can organize a competition for a teaching or research position only with the approval of the Ministry responsible, an approval that is required in the first 30 calendar days from the beginning of each semester of the academic year.

(2) The application for obtaining the approval of the Ministry responsible will be accompanied by the following documents:

a) the list of positions proposed for competition and their structure, signed and stamped by the rector;

b) the extract from the list of positions containing the positions put up for competition, signed by the rector, dean and the director of the department or the head of the doctoral school;

c) Affidavit of the rector of the University of Oradea, attesting that all the positions proposed to be put up for competition have in structure only disciplines from the curricula of the specializations/study programs legally established, including as a form of education and locality;

d) competition methodology.

(3) The competition procedures can be started only after the publication of the position put up for competition in the Official Gazette of Romania, Part III.

Art. 4. The teaching or research positions that the University of Oradea can put up for competition are:

- a) assistant professor;
- b) lecturer/head of works;
- c) associate professor;
- d) professor;
- e) research assistant;
- f) scientific researcher;
- g) scientific researcher 3rd degree;
- h) scientific researcher 2nd degree;
- i) scientific researcher 1st degree.

Art. 5. Teaching or research positions can be occupied by Romanian or foreign citizens, without any discrimination, according to art. 294 of Law no. 1/2011, with subsequent amendments and completions.

Art. 6. (1) The competition for the positions is proposed by the director of the department in whose structure the position is, by a *report approved by the department council and the faculty council*. The report must contain clarifications regarding the observance of the criteria for filling the vacancies in the public competition and the existence of the financial resources to support the position.

(2) The list of positions proposed for competition *is discussed in the Faculty Council* and is *approved by the dean* and submitted to the Board of Directors of the university for approval, according to

art. 213, paragraph (13) of the National Education Law (Law no. 1/2011), with subsequent amendments and completions.

(3) In the submission address, the positions will be individualized by indicating the position in the list of positions of the department, the disciplines in the structure of the position and the criteria for competition, mentioning whether the position is vacant or vacated.

Art. 7. (1) Announcements regarding the positions put up for competition can be made only for the positions that have received the favorable approval of the Ministry responsible.

(2) Positions not approved by the Ministry responsible cannot be put up for competition.

Art. 8. (1) The public announcement of public competitions for filling vacant teaching or research positions is made by the University of Oradea, at least 2 months before the date of the first competition test. The announcements are published *in the Official Gazette of Romania, on the specialized website administered by the ministry and on the first page of the university website (<u>www.uoradea.ro</u>), in a visible place.*

(2) Depending on the profile of the position and the needs for qualified staff of the university, the public announcement is made, at the proposal of the Faculty Council, in the national and international scientific publications renowned in the respective field.

(3) On the web page of the competition will be published, within the term provided in par. (1), at least the following information (NEW POSITION INTRODUCTION FORM, Section 3 of the User Manual for completing information on competitions for open-ended vacant teaching and research positions in higher education):

a) job description put up for competition;

b) attributions/activities related to the position put up for competition, including the didactic norm and the types of activities included in the didactic norm, respectively the research norm;

c) the minimum salary for the position at the time of employment;

d) the competition calendar;

e) the subject of the competition tests, including lectures, courses or the like, or the subjects from which the competition committee may choose the subject of the tests actually taken;

f) description of the competition procedure;

g) the complete list of documents that candidates must include in their competition dossier;

h) the address to which the competition dossier must be sent.

(4) Announcements for the positions of Associate Professor and University Professor, Grade II Scientific Researcher and Grade I Scientific Researcher will also be published in English.

(5) On the website of the competition and on the website of the university will be published, at the latest within 5 working days from the deadline for registration for the competition, for each of the registered candidates and in compliance with the protection of personal data, in the meaning of the law, the curriculum vitae and the verification sheet of the fulfillment of the minimum standards.

All information regarding the competition (public announcement regarding the positions put up for

competition; the topic of the positions put up for competition; date, time and place of the competition; the topic for the practical test and the topic of the didactic/scientific lecture, the topic of the public lecture) will be published on University of Oradea, www.uoradea.ro, the Job Contest button.

II. COMPETITION ENROLLMENT

Art. 9. (1) Registration for the competition for a teaching or research position begins on the day of publication of the position put up for competition in the O. G. of Romania, Part III.

(2) The registration ends 15 calendar days before the first competition test.

(3) The contest takes place no later than 45 days from the end of the registration period.

Art. 10. (1) The conditions for entering the competition for a teaching position are those provided by this article.

(2) The following conditions must be met cumulatively for the position of assistant professor:

a) to hold the scientific title of *doctor* in the field of disciplines within the position put up for competition (for History department) or in related fields (philosophy, history) for International Relations and European Studies and Political Science and Communication Sciences departments;

b) publication of at least 3 papers (articles, studies), in full or in summary, in specialized journals or in volumes of national or international scientific events;

c) The specific requirements to the three departments at the Faculty IRISPSC set out in *Annex 3.2* (see the valid annex for each department)

(3) For the positions of university lecturer/head of papers or 3rd degree scientific researcher, the following conditions must be met cumulatively:

a) to hold the scientific title of *doctor* in the field of disciplines within the position put up for competition (for History department) or in related fields (philosophy, history) for International Relations and European Studies and Political Science and Communication Sciences departments;

b) publication of at least 5 papers (articles, studies), in full or in summary, in specialized journals or in volumes of national or international scientific events;

c) elaboration, at least in electronic form, of a specialized didactic material for the students'

d) The specific requirements to the three departments at the Faculty IRISPSC set out in *Annex 3.2* (see the valid annex for each department)

use;

(4) For the position of associate professor or 2^{nd} degree scientific researcher, the following conditions must be met cumulatively:

a) to hold the scientific title of *doctor* in the field of disciplines within the position put up for competition (for History department) or in related fields (philosophy, history) for International Relations and European Studies and Political Science and Communication Sciences departments; b) fulfilling the national minimum standards for teaching positions, specific to the teaching position of associate professor, approved by order of the minister, according to art. 219, para. (1), lit. a) of Law no. 1/2011;

c) to meet the minimum standards established at the University of Oradea, supplemented with those specific to the to the three departments at the Faculty IRISPSC set out in *Annex 3.3* (see the valid annex for each department)

(5) For the position of university professor or 1st degree scientific researcher, the following conditions must be met cumulatively:

a) to hold the scientific title of *doctor* in the field of disciplines within the position put up for competition (for History department) or in related fields (philosophy, history) for International Relations and European Studies and Political Science and Communication Sciences departments;

b) holding the quality of doctoral supervisor;

c) fulfilling the national minimum standards for teaching positions, specific to the teaching position of university professor, approved by order of the minister, according to art. 219, para. (1), lit. a) of Law no. 1/2011;

d) to meet the minimum standards established at the University of Oradea, supplemented with those specific to the three departments at the Faculty IRISPSC set out in *Annex 3.3* (see the valid annex for each department);

Art. 11. (1) In order to enter the competition for a teaching and research position, the candidate draws up a file containing the documents mentioned in Annex 2 to this methodology.

(2) A CD/DVD or other electronic format, with its entire scanned content, is attached to the competition dossier for transmission to the competition committee.

Art. 12. (1) Candidates for the positions of associate professor or 2^{nd} degree scientific researcher must include in the competition file at least 3 names and contact addresses of personalities from the respective field, from the country or from abroad, outside the higher education institution whose position is issued at competition, which agreed to draw up letters of recommendation regarding the professional qualities of the candidate.

(2) Candidates for the positions of university professor or 1^{st} degree scientific researcher must include in the competition file at least 3 names and contact addresses of personalities from the respective field from abroad, who have agreed to draw up letters of recommendation regarding the professional qualities of the candidate.

Art. 13. The candidate's curriculum vitae must include information about:

a) studies completed and diplomas obtained;

b) professional experience and jobs;

c) the research and development projects has led as project director and the grants obtained, where such projects or grants exist, indicating for each source of funding, the volume of funding and the main publications or patents resulting;

d) awards or other elements of recognition of the candidate's scientific contributions.

Art. 14. The candidate's list of papers will be structured as follows:

a) the complete list of papers, of which, in the extract, <u>the list of the maximum 10 papers</u> considered by the candidate to be the most relevant for his own professional achievements, which are included in electronic format in the file and which can be found in the other categories of papers this article. *For the position of university professor*, the list of works will specify the works performed **after obtaining the habilitation certificate**.

b) doctoral thesis or theses;

c) patents and other industrial and intellectual property titles;

d) books and chapters in books;

e) articles/studies in full, published in journals from the main international scientific flow;

f) publications in full, published in papers of the main specialized international conferences;

g) other works and scientific contributions or, as the case may be, in the field of artistic creation.

Art. 15. (1) The competition file is made up by the candidate and, together with the electronic medium containing the scanned dossier, is submitted to the address of U. O. specified on the contest website, directly or through the postal or courier services that allow confirmation of receipt.

(2) On the web pages of the contest administered by the U. O. will be published, at the latest within 5 working days from the deadline for registration for the competition, for each of the registered candidates and in compliance with the protection of personal data, within the meaning of the law, the following:

a) curriculum vitae;

b) the file for verifying compliance with the minimum standards;

c) the nominal composition of the competition committee.

Art. 16. (1) In order to obtain the approval of the legal department of the higher education institution, each file must include the **resolution** regarding the verification of the information from the verification form provided in art. 17 para. (2) lit. b). This resolution shall be established by a **committee or scientific council appointed by decision of the rector**, on a proposal from the board of directors.

(2) The fulfillment by a candidate of the legal conditions for submission to the competition is certified by the opinion of the legal department of the higher education institution, based on the resolution from par. (1) and other documents required to enter the competition.

(3) The opinion is communicated to the candidate within a maximum of 48 hours from its issuance, but with a minimum of 5 working days before the first test of the competition.

III. COMPETITION CONDUCT

Art. 17. (1) The composition of the competition commission is established after the publication of the announcement of the competition for each position, for each position put up for competition.

(2) The composition of the competition committee includes at least 2 alternate members (one of whom may also act as chairman of the competition committee in case of unavailability of the appointed chairman).

(3) The council of the department in whose structure the post is located makes proposals for the nominal composition of the competition commission.

(4) The composition of the competition commission is presented by the dean to the faculty council, for approval, based on the proposals of the department council.

(5) The nominal composition of the competition commission, together with the **opinion of the faculty council**, is sent to the university senate and submitted to its approval.

(6) Following the approval by the university senate, the competition commission is appointed by the decision of the rector.

(7) Within 48 hours from the issuance of the rector's decision, the decision is sent to the Ministry responsible and published on the contest website. In the case of the positions of associate professor and university professor, 2nd degree scientific researcher and 1st degree scientific researcher, the composition of the commission is published in the Official Gazette.

Art. 18. (1) The competition committee consists of 5 members, including its chairman, specialists in the field of the position put up for competition or in related fields.

(2) In the event of the unavailability of a member's participation in the proceedings of the committee, that member shall be replaced by the alternate member appointed after the same procedure as the members of the committee.

(3) The decisions of the competition commission are taken by secret ballot of the members.

(4) A decision of the commission is valid if it has gathered the vote of at least 3 of its members.

(5) The proceedings of the competition committee shall be chaired by a chairman.

(6) The members of the commission can be from inside or outside the U.O., from the country or from abroad.

(7) In order to hold the position of Associate Professor, University Professor, 2nd Grade Scientific Researcher or 1st Grade Scientific Researcher, at least 3 members of the Commission must be from outside the U.O., from the country or from abroad.

(8) The members of the competition committee must have a higher or at least equal teaching or research title to the position put up for competition.

(9) For the exclusive purpose of participating in the competition commission, the equivalence of the didactic titles of the members from abroad with the didactic titles from the country is made by the approval by the university Senate of the nominal composition of the commission.

(10) The chairman of the competition committee may be the director of the department, the head of the doctoral school, the dean or vice-dean, a tenured university professor specializing in the field or in a related field, delegated for this purpose by the vote of the department council or the faculty council that organizes the competition. Upon the appointment of the chairman of the competition committee, an alternate

chairman will also be appointed (who will also be able to fulfill the function of alternate member of the competition committee).

Art. 19. (1) It is considered to be involved in the competition procedure the persons who:

a) participates in the decision-making process regarding the appointment of the competition commission;

b) are members or alternate members of the competition committee;

c) are involved in professional or administrative evaluation decisions in the competition;

d) are involved in resolving appeals.

(2) The following persons cannot be involved in the competition procedure:

a) they are spouses, affines and relatives up to the 3rd degree including with one or more candidates;

b) are employed in the same institution as a candidate holding a management position and are hierarchically subordinate to the candidate.

Art. 20. (1) The competition file is sent to the members of the competition commission starting with the closing date of the submission of the competition files, but not later than 5 working days before the first test of the competition.

(2) The file is sent, in the electronic format submitted by the candidate, after multiplying in 5 copies, through the university registry. The file can also be sent in electronic format, by e-mail.

(3) The file in printed format, submitted by the candidate, will be sent to the chairman of the commission.

Art. 21. (1) The competition committee evaluates the candidate from the perspective of the following aspects:

a) the relevance and impact of the candidate's scientific results;

b) the candidate's ability to guide students or young researchers;

c) the candidate's teaching skills;

d) the candidate's ability to transfer his or her knowledge and results to the economic or social environment or to popularize his or her own scientific results;

e) the candidate's ability to work in a team and the efficiency of his scientific collaborations, depending on the specifics of the candidate's field;

f) the candidate's ability to lead research and development projects;

g) the professional experience of the candidate in institutions other than the U.O.

(2) The competition committee has the obligation to verify and ascertain the candidate's compliance with the national minimum standards.

Art. 22. (1) The professional competencies of the candidate are evaluated by the competition committee based on the competition dossier and, additionally, by the following competition tests.:

(2) For the positions of **assistant professor**, the competition will contain a written test and/or a practical test (seminar, laboratory, project or others specific to the field).

The topic of the practical test is established by the chairman of the competition committee, in consultation with its members, and is announced at least 3 working days before the test on the competition website, together with the day, time and place of the competition, thus inviting all candidates to competition tests.

(3) For the positions of lecturer/head of works, associate professor and professor, the competition tests are:

(a) **Teaching lecture** - will take place in front of the students, in the presence of the competition commission or only of the competition commission, if during the competition there is no didactic activity. It will also contain a question-and-answer session.

The topic of the teaching lecture is established by the president of the competition commission, in consultation with its members, and is announced at least 3 working days before the test on the competition website and on the Faculty notice board, together with the day, time and place of the competition, thus inviting all candidates for the competition tests. The lecture will be marked with grades from 1 to 10, with 2 decimals allowed.

(b) The Public lecture on "Perspectives in the university career", of at least 45 minutes, in which the candidate presents the most significant previous professional results and the university career development plan. This test must also contain a question-and-answer session from the committee and the public. The lecture is marked with grades: unsatisfactory, satisfactory, good, very good, excellent.

Art. 23. (1) For each position, the competition commission decides the hierarchy of candidates and nominates the candidate who has met the best results.

(2) The chairman of the competition committee shall draw up a report on the competition, based on the assessment reports drawn up by each member of the competition committee and in compliance with the hierarchy of candidates decided by the committee.

(3) The report on the competition is approved by decision of the competition commission and is signed by each of the members of the competition commission and by the chairman of the commission. The result of the contest is published on the web page of the contest, within 2 working days from the end of the contest.

(4) The chairman of the competition commission sends the report on it, approved by decision of the commission, the assessment reports and the original file of the candidate for the management of the faculty / department / center, respecting the term provided for the competition.

Art. 24. (1) The competition files, including the report on the competition, are submitted to the dean of the faculty, or to the vice-dean responsible, who organizes their discussion in the faculty council and ensures the conditions for consulting the competition materials by the council members.

(2) The validation of the competition requires the presence of two thirds of the members of the faculty council.

(3) The faculty council examines the observance of the procedures and gives or does not give its opinion to the report on the competition from this perspective. Any vote against or abstention will have to be justified and has the right of veto in case of proof of violation of the legal procedures in force.

(4) The hierarchy of candidates established by the competition commission cannot be modified by the faculty council.

Art. 25. Based on the decision of the faculty council, an extract of the minutes of its meeting is drawn up, to which is attached a copy of the convening notice of the meeting (with the signatures of all those present). These documents are added to the file of each candidate and are forwarded to the U.O. Human Resources Service.

Art. 26. (1) The competition files are sent to the university senate.

(2) Following the presentation by a member of the management of the U.O. Senate of the manner of conducting the competition, of the conclusions of the competition commission and of the faculty council, the U.O. analyzes the observance of the procedures established by the U.O.'s own methodology. and approves or disapproves the report on the contest. The hierarchy of candidates established by the competition commission cannot be modified by the university senate.

(3) The decision of the senate is taken with the vote of the simple majority of the present members.

(4) In order for the sitting to be legally constituted, the number of members of the senate present must represent *at least 2/3 of its total number of members*.

Art. 27. (1) The appeals may be filed exclusively for non-compliance with legal procedures. Appeals Board

(2) If a candidate has elements that can prove non-compliance with the legal competition procedures, the candidate may file an appeal within 3 working days from the communication of the result. The appeal is formulated in writing, is registered at the U.O. and shall be settled by the Appeals Board. The solution is announced in no more than 2 working days on the contest website.

(3) In order to establish the composition of the Appeals Board, the same procedure is followed as when establishing the composition of the competition commission. The members of the competition committee cannot be part of the Appeals Board. Following the approval by the university senate, the Appeals Board is appointed by decision of the rector.

(4) The non-compliance of the provisions of the own methodology by the persons with attributions in the procedure of organization and development of the competition constitutes a disciplinary violation and is sanctioned in accordance with the provisions of Law 1/2011 or other legal provisions, depending on the deed.

Art. 28. (1) The appointment and the granting of the afferent university title by the U.O., following the approval of the competition result by the university senate, is made by the decision of the rector, starting with the first day of the semester following the contest.

(2) The decision to appoint and award the related university degree by the U. O., together with the competition report, shall be sent by the U. O. the Ministry and the C.N.A.T.D.C.U., within 2 working days from the issuance of the appointment decision.

Art. 29. In case the position put up for competition has not been filled, the competition may be resumed, in full compliance with the competition procedure.

Art. 30. In the situation where following the winning of a competition by a candidate, one or more

persons from the U.O. is to be in a situation of incompatibility, according to art. 295 paragraph (4) of Law no. 1/2011, the appointment and the granting of the university degree by the U. O. it takes place only after the situation/situations of incompatibility have been resolved. The manner of resolving the situation of incompatibility shall be communicated to the Ministry within 2 working days from the settlement.

Art. 31. The University of Oradea will draw up an annual report, no later than September 1, on the organization, development and completion of competitions for teaching positions. The report will be submitted for notification to the ministry and the C.N.A.T.D.C.U.

Art. 32. For the research positions, the provisions of Law no. 319/2003, by exception from the provisions of art. 18 paragraph (1) and art. 10 paragraph (3) of this procedure.

Art. 33. In order to carry out the competitions for the research positions at the University of Oradea, the attributions provided by Law no. 319/2003 are fulfilled as follows:

a) those provided for the scientific council of the unit, by the faculty council;

b) those provided for the scientific secretary of the unit, by the director of the department, the head of the doctoral school, dean or vice-dean, as the case may be.

Art. 34. This procedure enters into force on the date of its approval in the university senate.
