### I. General aspects

### Art. 1.

**1.1.** At the Faculty of History, International Relations, Political Science and Communication, the University of Oradea, for the Department of International Relations and European Studies and for the Department of Political Science and Communication, the vacant teaching and research positions are filled for undetermined period only through open contest, organized in accordance with the:

- Law 1/2011.

- GD no. 457/2011 on approving the Framework Methodology for teaching and research vacancy-filling in higher education, modified by GD 36/2013 and GD 883/2018;
- E.G.O. no 96/2016 on the modification and completing of certain normative acts in education, research, training, and health;
- MO no 6129/2016 on the approval of the minimum and mandatory standards required for the award of higher education teaching qualifications, professional research and development degrees, the status of doctoral supervisor and the certificate of habilitation (Committee 25 Sociology, political and administrative sciences),
- the specific standards regarding the external evaluation of the academic quality for the BA and MA study programs, pertaining to the specialized committee no. 4 Social, political and communication sciences, approved by the ARACIS (Romanian Agency for Quality Assurance in Higher Education) Council in 2017
- The contest methodology for filling vacancies in teaching and research at the University of Oradea, approved by the Senate of the University during the meeting of 26.11.2018;
- The criteria for filling vacancies in teaching, valid as of the second semester of the academic year 2018-2019, approved by the Senate of the University by SD 44/25.02.2019
  - This methodology for contests for vacancy filling for undetermined period
  - Any other normative acts in force at the date of the contests

### 1.2.

For the research vacancies, the stipulations of Law no.319/2003 are applied, by exception to the stipulations of art.21 paragraph (1) and art.12 paragraph (3) of the Contest methodology for teaching and research vacancy filling at the University of Oradea

- For the organization of the contests of research vacancies at the University of Oradea, the responsibilities stipulated by Law no.319/2003 are fulfilled as follows:
  - a) by the Council of the Faculty for the jobs of the unit's scientific council;
- b) by the director of the department, by the head of the doctoral school, dean, or vicedean, depending on the case, for those related to the scientific secretary of the unit

### **Art. 2.** Advertising the teaching positions and candidate applications

- 2.1. At the Faculty of History, International Relations, Political Science and Communication Sciences (IRISPSC), vacancies for teaching and research positions from the fundamental fields Human Sciences and Arts and Social Science, sub-fields history, political Sciences, the Departments of International Relations and European Studies, respectively Political Science and Communication Sciences, vacancies for teaching and research positions in the Member States of the departments, approved by the Senate of the University of Oradea, depending on their development strategy and in compliance with the provisions of ARACIS standards (Specialized Committee no. 4 Political and communication sciences) regarding the coverage of teaching positions with tenured teachers.
- **2.2.** The advertising of vacancies is proposed by the head of the department in whose structure the position is, by a report approved by the Department Council and the Faculty Council. The report must contain clarifications regarding the observance of the criteria for advertising the vacancies in the public contest and the existence of financial resources to support the position (HS 44/25.02.2019).

- **2.3.** The list of positions proposed for filling by public contest is approved by the Dean and submitted to the Board of Directors of the University for approval, according to art. 213, paragraph (13) of the National Education Law (Law no. 1/2011) with subsequent amendments and completions.
- **2.4.** The public announcement of public contests for filling teaching or research vacancies is made by the University of Oradea based on its own contest Methodology for filling vacant teaching and research positions, based on *Methodology for filling vacant teaching and research positions* and *Calendar of contests for published positions in the Official Gazette*.
- **2.5.** The applications for the contest for the vacant teaching positions is made by submitting the contest file to the Department of Human Resources within the University of Oradea. The contest file must be drawn up in accordance with the *List of documents required for enrolment in the contest and the criteria for filling teaching positions* provided in the own contest Methodology for filling vacant teaching and research positions of the University of Oradea.

### 2. Preparation of the contests at the Department level

- **Art. 3.** After the publication in the Official Gazette, the departments provide the following information regarding the positions advertised for contest to the management of the University of Oradea to be displayed on the web pages dedicated to the contest:
  - description of the open position
  - tasks / activities for the open position, including teaching norm and types of activities included in the job description;
  - minimum wage classification of the position at the time of employment;
  - calendar of the contest:
  - contest topics;
  - selected bibliography;
  - description of the contest procedure;
  - list of documents that the candidates must include in the contest file;
  - address where the contest file must be submitted.
- **Art. 4.** The directors of departments will submit to the Faculty Council the committee proposed for the execution of the contests, respectively proposals for the members of the scientific committee for the endorsement of the verification sheets stipulated at art. 8. These proposals will be centralized, endorsed in the meeting of the Council. The composition of the contest committee, together with the opinion of the Faculty Council, is sent to the University Senate and subject to its approval. Following the approval by the University Senate, the contest committee is appointed by the decision of the Rector.

### Art. 5. Contest committee

- **5.1.** The establishment of the contest committee is made after the vacancy filling notice is published, for each vacancy advertised.
- **5.2.** The contest committee consists of 5 members, including its president, specialists in the field or in related fields. The contest committee includes a minimum of 2 alternate members (one of which should be able to fulfil the title of president of the contest committee in case the designated is not available).
- **5.3.** The decisions of the contest committee are taken by a simple majority of the members' vote.
- **5.4.** The contest committee works are led by a president.
- **5.5.** Committee members may be from within or outside the UO, in the country or abroad.
- **5.6.** For the position of Associate Professor, Professor, Senior Researcher II, and Senior Researcher I, at least 3 members of the committee must be from outside the UO, from the country and/or abroad.
- **5.7.** The contest committee members must have a teaching or research title superior or at least equal to that of the open position.

- **5.8**. For the sole purpose of participating in the contest committee, the equivalence of the foreign members' teaching titles with the Romanian teaching titles is made by the University Senate approval of the components of the contest committee.
- **5.9.** The president of the contest committee can be the dean of the department, the vice-dean, the head of the department, the head of the doctoral school, or a member of the department council.

### II. Applying for the contest

**Art. 6.** The conditions for entry the contest for filling a teaching position are the following:

### 6.3 For the position of Associate Professor/scientific researcher II, the following are cumulatively required:

- a) holding a doctoral degree;
- b) fulfilment of the national minimum standards for teaching positions, specific to the teaching position of associate professor, approved by Order of Minister, according to art. 219, paragraph (1), lett. a) of Law no. 1/2011;
  - c) To fulfil the specific requirements, presented in Annexes 3.3 and 3.4 (as applicable).

### **6.4.** For the position of Professor, the following are cumulatively required:

- a) holding a doctoral degree;
- b) holding the quality of doctoral supervisor;
- c) fulfilment of the national minimum standards for teaching positions, specific to the teaching position of university professor, approved by Order of Minister, according to art. 219, paragraph (1), lett. a) of Law no. 1 / 2011;
  - d) To fulfil the specific requirements presented in Annexes 3.3 and 3.4 (as applicable).

### DOCUMENTS NECESSARY FOR THE APPLICATION

- **Art. 7.** The application for the contest for teaching positions at the Departments of International Relations and European Studies, respectively Political Sciences and Communication Sciences, is made according to the provisions of the own *contest Methodology for filling vacant teaching and research positions at the University of Oradea*, by submitting the application file to the Human Resources Department within the University of Oradea, directly or through the postal or courier services that allow confirmation of receipt.
- **Art. 8**. The application file is constituted by the candidate and will include the verification files for the fulfillment of the national minimum standards, those of the University of Oradea, and the specific requirements and criteria (Annexes 3.5, 3.6, 3.7, 3.8, as applicable).
- **Art. 9.** A CD / DVD or other electronic format, with its entire scanned content, is attached to the application file, in order to be sent to the contest committee.
- **Art. 10.** The fulfilment by a candidate of the legal conditions for submission to the contest is certified by the approval of the legal office of the U.O.

### **III.** Execution of the contest

- **Art. 11.** The competition committee evaluates the candidates for the positions based on the following aspects:
- a) the relevance and impact of the candidate's scientific results;
- b) the candidate's ability to guide students or young researchers;
- c) the didactic competences of the candidate;
- d) the candidate's ability to transfer his knowledge and results to the economic or social environment or to popularize his own scientific results;
- e) the candidate's ability to work in a team and the efficiency of his scientific collaborations, depending on the specifics of the job field;

- f) the candidate's ability to lead research and development projects;
- g) the professional experience of the candidate in other institutions than the University of Oradea.

The contest committee must verify and ascertain the fulfilment by the candidate of the national minimum standards, those of the University of Oradea, as well as the specific requirements and criteria.

- **Art. 12.** The professional competences of the candidate are evaluated by the contest committee based on the application file and, additionally, by the following tests:
- **12.3** The competition for the position of <u>associate professor / scientific researcher degree II</u> <u>and university professor / scientific researcher degree I</u> consists of giving a lecture with a didactic character and a public lecture
- didactic lecture. The syllabus related to the contest is published on the web page of the University, respectively on the notice board of the Faculty once the announcement of the vacancy for the contest is published. The topic of the didactic lecture is established by the committee and is announced to the candidates at least 3 working days before the presentation, on the UO website, respectively on the Faculty notice board. The didactic lecture is held in the presence of the competition committee and / or of the invited students and necessarily contains a question-and-answer session. The defence of the lecture is to be evaluated with a grade from 1 to 10. 2 decimal points are allowed.
  - the public lecture entitled "Perspectives of the university career", referring to the career path of the candidate has a duration of maximum 45 minutes, during which the candidate will present the most significant professional results achieved and a career plan. This test also contains a question-and-answer session from the committee and the public. The lecture is marked with grades: unsatisfactory, satisfactory, good, very good, excellent.

The calculation of the score as a result of the contest file analysis is done based on the indicators stipulated in the evaluation grid (Annex 3.3 sau 3.4, as applicable).

### Art. 13.

- **13.1** For each position, the competition committee decides the hierarchy of candidates and nominates the candidate who has achieved the best results.
- 13.2 The chairman of the contest committee draws up a report (Annex 6) on the contest, based on the assessment reports (Annexes 5.1 or 5.2, as applicable) drawn up by each member of the contest committee and in compliance with the hierarchy of candidates decided by the committee.
- **13.3** The report on the contest is approved by decision of the contest committee and is signed by each of the members of the contest committee and by the chairman of the committee.
- **13.4** The result of the contest is published, within 2 working days from the end of the competition, on the UO website.
- **13.5** The chairman of the committee sends the report on it, approved by decision of the committee, the assessment reports, and the original file of the candidate to the management of the faculty / department / centre, respecting the term provided for the competition.
- **13.6.** The candidate may file an appeal, within 3 working days from the communication of the result, in writing and registered at the UO registry. The appeal is resolved by a specially appointed committee, of which the members of the contest committee cannot be part.
- **Art.14** This procedure completes the *contest Methodology for filling vacant teaching and research positions of the University of Oradea*, approved by the University Senate in the meeting of 26.11.2018 with specific requirements and criteria for the departments and enters into force as of the date of its approval in the University Senate.

- 2. The books, volumes or dictionaries considered are those published by publishing houses of international prestige (category A1) or, to publishing houses of recognized prestige (category A2), or which are present in at least 6 libraries in Worldcat.
- 3. The following are considered to be languages of international circulation: English, French, German, Italian and Spanish.
- 4. For certain categories of publications (see grid below), the multiplication coefficient m applies, which has the following values: 2, if the publication has been published by a foreign publishing house, with international peer review, and is written in a international language; 1.5, if the publication is written in a language of international circulation, but has not appeared at a publishing house abroad, with international peer review; 1, in other cases
- 5. The recognized international databases are the following: ISI Web of Knowledge, SCOPUS, EBSCO, ProQuest, CEEOL, Ulrich, ERIH, Index Copernicus, CSA, GESIS, IBSS, SAGE, OVID, ECOLIT, Psychlit, PubMed, Elsevier, Springerlink, Persée, DOAJ, Jstor, SSRN, REPEC, Informa, Project MUSE, HEIN Online
- 6. n indicates the number of authors of a publication in which the candidate is the author or co-author
