# OWN COMPETITION PROCEDURE OF THE FACULTY OF CONSTRUCTION, CADASTRE AND ARCHITECTURE FOR OCCUPATION OF TEACHING AND RESEARCH POSITIONS

Valid starting with the academic year 2022-2023 - sem. I

The procedure was approved at the meeting of the Faculty Council on 28.10.2022

In the Faculty of Civil Engineering, Cadastre and Architecture, vacant teaching or research positions are filled, for an indefinite period of time, only by *public competition*, according to:

- Law nr. 1/2011,
- H.G. no. 457 on the approval of the Framework Methodology of competition for filling vacant teaching and research positions in higher education (published in M.O. Part I, no. 371/26.05.2011)
- Own methodology of competition for the indefinite occupation of teaching and research vacancies in the University of Oradea, approved in the Senate of the University of Oradea on 26.11.2018
- the provisions of OMENCS nr. 6129 of 2016 on the minimum standards for accepting participation in competitions for conferring teaching titles in higher education and professional degrees of research and development;
- the present procedure, hereinafter referred to as the Own Procedure of the Faculty of Civil Engineering, Cadastre and Architecture;
- other normative acts in force at the time of the contests.

The competition for filling the teaching and research positions vacant for an indefinite period of time of the Faculty of Constructions, Cadastre and Architecture is carried out in accordance with this procedure and with *the "Own methodology of competition for filling the teaching and research vacancies in the University of Oradea"* adopted by the Decision of the University Senate Annex 11/26.11.2018 regarding the update of nexa 3 to the Charter of the University of Oradea.

The competition methodology of the University of Oradea is available on the website of the University of Oradea <u>www.uoradea.ro</u>.

All information regarding the contest will be published on the website of the University of Oradea, www.uoradea.ro, the button Contests on posts.

Taking into account the specifics and requirements of each field, the Faculty of Constructions, Cadastre and Architecture elaborates its own competition procedure which is a complement to the "*Own competition methodology for filling the teaching and research positions vacant in the University of Oradea*" adopted by the Decision of the University Senate Annex 11/26.11.2018 of the University of Oradea.

The general aspects, the registration for the competition and the development of the competition, as well as the annexes can be found in the "*Own methodology of competition for filling the teaching and research positions vacant in the University of Oradea*". The exceptions

are Article 9, Annexes no. 3 and no. 6, whose changes and format are presented in the own procedure of the Faculty of Constructions, Cadastre and Architecture.

#### Art. 9

(1) The specific conditions for registering to the competition for occupying a teaching position of a university assistant and lecturer are those provided by the present article. At the same time, this article contains additional conditions regarding the application of the specific minimum standards for the positions of associate professor and university professor, contained in Annexes 3 and 6.

(2) For the position of a university assistant in the field of Civil Engineering / Geodetic Engineering, the following are cumulatively required:

- a) holding the PhD diploma in the field of the post advertised or in nearby fields;
- b) publication of at least 3 scientific papers ( in extenso or in abstract) in a journal/volume of reference conference for the field of the post indexed in an international database [BDI], journals quoted or indexed ISI Thomson Reuters category A-CNCSIS; ISI Proceedings.
- c) Promotion of three competition tests, regarding the evaluation of specialized knowledge in direct accordance with the disciplines of the position put up for competition:
  - practical test (holding a seminar or a practical work in front of students and in the presence of the competition commission);
  - 2) oral test.
  - 3) written test

The result of the competition tests is assessed by each member of the commission through marks from 1 to 10, the grade of the test representing their arithmetic mean.

(3) For the position of university assistant in the field of architecture, the following are required cumulatively:

- a) holding a PhD degree in the field of the position put up for competition or in related fields;
- **b**) publication of a scientific paper in a magazine / scientific conference volume.
- c) two architectural / urban planning / restoration / design / specialized projects or studies built / authorized by local / regional or national complexity;
- **d**) passing the competition tests, i.e. the evaluation of specialized knowledge in direct accordance with the disciplines for the position put up for competition:
  - written test and/or practical test (seminar, laboratory, project or others specific to the field of architecture);

*the score* calculated based on the CNATDCU grid, Architecture field, according to Annex no. 3;

The result of tests 1 and 2 is assessed by each member of the committee with grades from 1 to 10. The final score will be the sum of the scores of tests 1 and 2.

(4) For the position of university lecturer in the field of Civil Engineering / Geodetic Engineering, the following are cumulatively required:

- a) holding the PhD diploma in the field of the post advertised or in nearby fields;
- b) publication of at least 5 papers (in extenso or in abstract) in a journal/conference volume of reference for the job field indexed in an international database [BDI], journals quoted or indexed ISI Thomson Reuters - category A-CNCSIS; ISI Proceedings.
- c) publishing at least one specialized book in one of the disciplines of the post under the aegis of nationally or internationally recognized publishing houses.
- d) elaboration, at least in electronic form, of a specialized teaching material for the use of students in the field of the advertised position;

(5) For the position of a university lecturer/head of works in the field of architecture, the following are cumulatively required:

- a) holding a PhD degree in the field of the position put up for competition or in related fields;
- **b**) publication of a scientific paper in a magazine / scientific conference volume;
- c) five studies / architecture design/ urban planning / restoration / design / specialty built / authorized studies of local / regional or national complexity with part / structure / location / conceptual substantiation;
- **d**) the development, at least in an electronic form, of a specialized didactic material for the students;
- e) passing the competition tests, i.e. the evaluation of specialized knowledge in direct accordance with the disciplines for the position put up for competition:
  - 1) *didactic lecture* (on the topic of the position's disciplines);
  - the score calculated based on the CNATDCU grid, Architecture field, according to Annex no. 3;

The result of tests 1 and 2 is assessed by each member of the committee with grades from 1 to 10. The final score will be the sum of the scores of tests 1 and 2.

(6) For the position of associate professor are required cumulatively:

a) holding the PhD diploma in the field of the post put up for competition or in nearby fields;

**b**) the fulfillment of the national minimum standards for the occupation of teaching positions,

specific to the teaching position of associate professor, related to the field of the post put up for competition, approved by order of the minister, according to art. 219, para. (1), lit. a) of Law no. 1/2011;

c) publication with ISBN of at least one book / course material / university textbook / monograph in the field of the position's disciplines;

(7) For the position of university professor are required cumulatively:

a) holding the PhD diploma in the field of the post put up for competition or in nearby fields;b) holding the quality of doctoral supervisor;

**c**) the fulfillment of the national minimum standards for the occupation of teaching positions, specific to the teaching position of university professor, related to the field of the post put up for competition, approved by order of the minister, according to art. 219, para. (1), lit. a) of Law no. 1/2011;

**d**) publication with ISBN of at least one book / course material / university textbook / monograph in the field of the position's disciplines;

Final provisions

- 1. For positions put out for competition that belong to other fields, the CNADTCU grid specific to the field will be used.
- 2. The present own competition procedure of the Faculty of Civil Engineering, Cadastre and Architecture for filling the vacant teaching and research positions was approved by the Council of the Faculty of Constructions, Cadastre and Architecture at its meeting on 28.10.2022 and will enter into force following the approval of the SENATE OF THE UNIVERSITY OF ORADEA
