#### I. GENERAL ASPECTS

#### Art. 1.

In the University of Oradea (U.O) and within the **Faculty of Environmental Protection** which is part of the University of Oradea, vacant teaching or research positions are filled for an indefinite period, only through public competition, in accordance with:

- Higher Education Law no. 199/2023
- G.D. no. 1339/2023 regarding the approval of the framework competition Methodology for filling vacant teaching and research positions in higher education,
- Own competition methodology for filling vacant teaching and research positions in the University of Oradea, approved by the U.O. Senate on 29.01.2024,
- this procedure, hereinafter referred to as the Own Competition procedure for filling vacant teaching and research positions at the Faculty of Environmental Protection.

#### Art. 2.

- (1) The occupation of a vacant teaching or research position in the U.O. is carried out through a public competition. Employment for an indefinite period, on any teaching or research position, is possible only for the candidate who obtained the highest score following the public competition organized by the U.O..
- (2) Romanian or foreign citizens may participate in the competition for a teaching or research position, without any discrimination, according to the law.

#### Art. 3.

(1) The own methodology cannot refer to seniority and cannot contain discriminatory provisions regarding persons from outside the institution or the country compared to persons from the institution or the country.

#### Art. 4.

- (1) The teaching positions that the Faculty of Environmental Protection tender are:
  - a) assistant professor;
  - b) university lecturer;
  - c) associate professor;
  - d) professor.
- (2) In the U.O., the research positions are:
  - a) research assistant;
  - b) scientific researcher;
  - c) scientific researcher grade III;
  - d) scientific researcher grade II;
  - e) scientific researcher grade I.
- (3) The equivalence of research positions with teaching positions operates in both directions, only with the approval of the University Senate, and is as follows:
  - a) scientific researcher is equivalent to assistant professor, for persons holding a doctoral degree;
  - b) scientific researcher III is equivalent to university lecturer;



- c) scientific researcher II is equivalent to associate professor;
- d) scientific researcher I is equivalent to university professor.
- (4) Within the U.O., in addition to other conditions established by law, the position of scientific research assistant can only be occupied by persons who are doctoral students or who hold a doctoral degree.
- (5) Within the U.O., in addition to other conditions established by law, the positions of scientific researcher, scientific researcher III, scientific researcher II and scientific researcher I can only be held by persons holding a doctoral degree.
- (6) The minimum conditions for registering in the competition for the occupation of a vacant research position are established by the U.O., depending on the specifics of the position and in relation to the minimum national standards, approved according to art. 156 paragraph (2) from the Higher Education Law no. 199/2023, with subsequent amendments and additions, and according to the provisions of Law no. 319/2003 regarding the Statute of research-development personnel, with subsequent additions, as appropriate.

#### Art. 5.

- (1) The minimum requirements and standards for occupying the teaching position of **assistant professor** are as follows:
  - a) the candidate must hold a doctoral degree or be enrolled in a doctoral program, without exceeding the maximum period of studies, which includes extensions admissible according to the law;
  - b) publication of at least one paper (article, study), in extenso, in specialized journals or in volumes of national or international scientific events.
- (2) The minimum requirements and standards for occupying the teaching position of **university lecturer** are as follows:
  - a) holding of a doctoral degree/diploma;
  - b) publication of at least 5 papers (articles, studies), in extenso, in specialized journals or in volumes of national or international scientific events;
  - c) the elaboration of a specialized didactic material (at least in electronic format), posted on the e-learning platform of the U.O. (e.uoradea.ro), in the field of the job's disciplines, or a specialized book, in the field of the job.
- (3) The requirements and standards for occupying the teaching position of **associate professor** are as follows:
  - a) holding a doctoral degree/diploma;
  - b) meeting the minimum national standards for the position of **associate professor**, standards approved according to art. 156 of the Higher Education Law no. 199/2023, with subsequent amendments and additions.
- (4) The requirements and standards for occupying the teaching position of **university professor** are as follows:
  - a) holding a doctoral degree/diploma;
  - b) holding the habilitation certificate;



c) meeting the minimum standards for occupying the position of university professor, standards approved according to art. 156 of the Higher Education Law no. 199/2023, with subsequent amendments and additions.

## II. ORGANIZATION AND CONDUCT OF THE COMPETITION FOR OCCUPYING VACANT TEACHING AND RESEARCH POSITIONS IN HIGHER EDUCATION INSTITUTIONS

#### II.1. General framework

#### Art. 6.

- (1) The U.O. can organize a competition to fill a teaching or research position only if it is declared vacant.
- (2) A position is considered vacant if it is provided as such in the list of job titles, drawn up annually, or if it is vacant during the academic year.
- (3) The position is vacated in one of the following ways:
  - a) termination of the individual employment contract, according to the law;
  - b) the transfer of the person occupying the position to another position within the same higher education institution, as a result of winning a competition or following promotion in the teaching career, under the law provisions.
  - (4) Teaching and research positions cannot be tendered by transforming an occupied position into a higher rank position.

#### Art. 7.

- (1) The U.O. can organize a competition for the occupation of a teaching or research position for an indefinite period, only after the Ministry of Education publishes the position proposed for competition in the Official Gazette of Romania, Part III.
- (2) In order to publish the announcement in the Official Gazette of Romania, Part III, the U.O. submits the following documents to the Ministry of Education:
  - a) the list of positions proposed for competition and their structure, signed by the rector and stamped;
- b) the excerpt from the list of positions containing the positions tendered for competition, signed by the rector, dean, head of department or head of the doctoral school;
- c) in the case of teaching positions, the declaration on the rector's own responsibility certifying that all teaching positions proposed to be tendered have only subjects from the curricula of legally established specializations/study programs, including the form of education and the locality of their development;
- (3) The transmission to the Ministry of Education of the request regarding the publication in the Official Gazette of Romania, Part III, of the tendered positions is carried out within 30 working days from the beginning of each semester of the academic year.
- (4) The Ministry of Education verifies the submitted documentation and the position structure, in relation to the legal provisions in force, and submits it to the Official Gazette of Romania, in order to publish the proposed positions.



- (5) The initiation of tender procedures can only be started after the publication in the Official Gazette of Romania, Part III, of the positions proposed to be tendered. The first competition test must be scheduled at least two months after the publication of the announcement in the Official Gazette. The competition registration period begins with the day of publication of the announcement in the Official Gazette of Romania, Part III, and ends 15 working days before the first competition test.
- (6) The proposal to organize the competition for a vacant position is made by the head of the department or the head of the doctoral school in the structure of which the position is located, through a report approved by the Department Council or the Doctoral School Council and the Faculty Council.
- (7) The list of positions proposed to be filled by competition is approved by the Faculty Council, approved by the dean and forwarded to the Administrative Council of the U.O. for approval, according to art. 139 letter. d) from the Higher Education Law no. 199/2023, with subsequent amendments and additions.
- (8) Announcements regarding the competition for vacant teaching and research positions are published:
- a) in a visible place, on the main page of the U.O. website.
- b) on a specialized website, administered by the Ministry of Education, called the webpage of the competition for filling vacant teaching and research positions in higher education.
- (9) On the platform administered by the Ministry of Education, dedicated to the publication of teaching and research vacancies, the following information will be published:
  - a) brief description of the tendered position;
  - b) the teaching workload and the types of activities included in it, in the case of teaching positions, respectively the research workload, in the case of research positions, as well as other specific duties of the tendered position;
  - c) the minimum employment salary corresponding to the tendered position;
  - d) the competition calendar;
  - e) the theme of the competition tests, including the lectures, courses or other similar topics, or the topics from which the competition committee can choose the theme of the tests actually held;
  - f) description of the competition procedure;
  - g) the complete list of documents that candidates must include in the competition file;
  - h) the address to which the competition file must be sent.
- (10) The announcements regarding the positions of university lecturer, university professor, scientific researcher II and scientific researcher I will also be published in English.

#### Art. 8.

- (1) They will be published on the website of the UO within 5 working days, after the end of the registration period, complying with the personal data protection according to Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals regarding the processing of personal data and regarding the free movement of such data and the repeal of Directive 95/46/EC (General Data Protection Regulation), for each candidate, information as follows:
  - a) curriculum vitae;
  - b) the compliance criteria checklist for meeting the minimum requirements and standards;



- c) complete list of publications.
- (2) The same data are uploaded by the U.O. on the competition webpage, managed by the Ministry of Education.

#### Art. 9.

- (1) Competitions are open.
- (2) The competition methodology cannot contain discriminatory provisions regarding candidates based on gender, ethnic or social origin, citizenship, religion or belief, disabilities, political opinions, social or economic condition.
- (3) The description of the tendered position will be made in comprehensive terms, which correspond to the real needs of the U.O., taking into account not to artificially limit the number of potential candidates.

#### Art. 10.

- (1) Persons considered to be involved in the competition procedure are those who:
  - a) take part in the decision-making process regarding the appointment of the competition committee;
  - b) are members or substitute members of the competition commission;
  - c) are involved in professional or administrative evaluation decisions within the contest;
  - d) are involved in the settlement of appeals.
- (2) Persons who are in one of the situations provided for in art. 201 paragraph (4) from the Higher Education Law no. 199/2023, with subsequent amendments and additions cannot be involved in the competition procedure..
- (3) In the event that, following the winning of a contest by a candidate, one or more persons from the U.O. will find themselves in a situation of incompatibility according to the provisions of art. 3 paragraph (3) from this methodology, the appointment and granting of the university title by the U.O. or the professional research-development degree can only take place after the resolution of the incompatibility situation/situations. The method of solving the incompatibility situation is communicated to the Ministry of Education, within two working days from the solution.

#### II.2. Competition registration

#### Art. 11.

- (1) In order to register for the competition for a teaching and research position, the candidate prepares a file, in printed format, containing the following documents (Annex 2):
- a) the application for registration to the competition, signed by the candidate, which includes a declaration on his own responsibility regarding the veracity of the information presented in the file (Annex 1);
- b) a proposal for the development of the candidate's university career, both from a teaching point of view, in the case of teaching positions, and from the point of view of scientific research activities; the proposal is drawn up by the candidate, it contains a maximum of 10 pages and is one of the main criteria for making a decision on the candidates;
  - c) curriculum vitae signed by the candidate (Europass model);
  - d) list of publications, signed by the candidate;



- e) compliance criteria checklist for meeting the minimum requirements and standards (Annex 3), the standard template of which is provided by the faculty's own procedure. The standards requested at the U.O. level cannot deviate from the minimum national standards approved according to art. 156 paragraph (1) letter a) and paragraph (2) from the Higher Education Law no. 199/2023, with subsequent amendments and additions. The checklist is completed and signed by the candidate;
- f) documents related to holding the doctoral degree: copy in accordance with the original of the doctoral degree and, in case it was obtained abroad, a copy in accordance with the original of the certificate of recognition or equivalence thereof;
- g) for candidates for the position of university professor, the copy of the minister's order certifying the qualification, and in case it was obtained abroad, the certificate of its recognition or equivalence by the Romanian state;
- h) the summary in Romanian and in a language of international circulation of the doctoral thesis and, as the case may be, of the habilitation thesis, on a maximum of one page for each language;
- i) declaration on the candidate's own responsibility indicating the situations of incompatibility provided by the Higher Education Law no. 199/2023, with subsequent amendments and additions, in which it would be in case of winning the competition or the absence of these incompatibility situations;
- j) in the cases provided for in art. 4 paragraph (5) and (6) of this methodology, copies conforming to the original, certifying the possession of the respective medical titles;
- k) copies of other diplomas certifying the candidate's studies (baccalaureate diploma, bachelor's degree, master's degree);
- l) copies of diploma supplements, transcripts or school reports issued for each cycle of studies completed;
- m) copy of the identity card or, if the candidate does not have an identity card, of the passport or another identity document drawn up for an equivalent purpose to the identity card or passport;
- n) if the candidate has changed his/her name, copies of documents attesting to the change of name, namely the marriage certificate or proof of name change;
- o) a maximum of 10 publications, patents or other works of the candidate, in electronic format, selected by him/her and considered to be the most relevant for his/her own professional achievements;
- p) for candidates for the position of university lecturer/scientific researcher II, respectively university professor/scientific researcher I: 3 letters of recommendation, according to art. 13 of this methodology;
  - q) criminal record certificate;
  - r) behavioral integrity certificate;
- s) medical certificate, issued on a specific form, adopted by joint order of the Ministry of Education and the Ministry of Health;
- t) the medical certificate for exercising the teaching profession, issued according to the provisions of the joint order of the Ministry of Education and the Ministry of Health;
  - u) consent on the processing of personal data by the U.O.
- (2) The candidate's curriculum vitae must include:
  - a) information about the studies completed and the diplomas obtained;
  - b) information about professional experience and relevant jobs previously held;



- c) information about the research and development projects the candidate has led as a project manager and the grants obtained, if there are such projects or grants, indicating for each funding source, the volume of funding and the main publications or patents results;
- d) information about awards or other recognition elements of the candidate's scientific contributions.
- (3) The documents provided for in paragraph (1) will be submitted both in written form and on electronic media, with its entire content scanned. The list of works, the curriculum vitae and the compliance criteria checklist will be scanned as separate files, not exceeding 10 MB together. The candidate's personal data will not appear on the scanned documents (photo, PIC, home address, signature, etc.).
- (4) The competition file is prepared by the candidate and submitted to the address of the higher education institution specified on the competition web page, directly or through courier services that allow confirmation of receipt. The competition file is sent to the members of the competition committee starting from the closing date of the process of submitting the competition files, but no later than 5 working days before the first test of the competition.

#### Art. 12.

The competition file will contain the articles/studies, publications produced by the candidate, relevant in the field of the job's disciplines, and their list will be structured as follows:

- a) the list of the maximum 10 publications considered by the candidate to be the most relevant for the field of disciplines included in the tendered position;
- b) doctoral thesis or theses;
- c) patents and other industrial/intellectual property titles;
- d) books and chapters in books;
- e) articles/studies in extenso, published in journals from the main international scientific stream:
- f) publications in extenso, appearing in papers of the main international specialized conferences;
- g) other works and scientific contributions.

#### Art. 13.

- (1) Candidates for the positions of associate professor or scientific researcher II must include in the competition file at least three letters of recommendation, regarding the professional qualities of the candidate, from personalities in the respective field, from the country (outside the U.O.) or from abroad.
- (2) Candidates for the positions of university professor or scientific researcher I must include in the competition file at least three letters of recommendation, relating to the candidate's professional qualities, from personalities in the respective field from abroad.
- (3) In the case of scientific fields with Romanian specificity, letters of recommendation for candidates for the positions of university professor or scientific researcher I can also be provided by personalities in the respective field from Romania, outside the U.O..

#### Art. 14.

(1) The fulfillment by a candidate of the legal conditions for taking part in the competition is certified by the opinion of the legal department of the U.O..



- (2) The legal opinion is issued by the specialized department, after the resolution of the scientific commission regarding the verification of the information from the checklist of the compliance with the minimum requirements and standards, provided for in art. 11 paragraph (1) letter e) from the present methodology. The scientific commission is appointed by the decision of the rector, at the proposal of the U.O. Administrative Council.
- (3) The legal opinion and the resolution of the scientific commission are communicated to the candidate within a maximum of 48 hours from issuance, but at least 5 working days before the first exam of the competition.

#### II.3. Conducting the competition

#### Art. 15.

- (1) The competitions may take place in maximum 45 days from the end of the registration period.
- (2) The competition consists in the evaluation of the scientific activity and teaching skills of the candidates for the didactic positions and, respectively, in the evaluation of the scientific activity and the research skills of the candidates for the research positions.

#### Art. 16.

- (1) Candidates who meet the legal conditions for taking part in the competition and have received the favorable legal opinion will be invited by the U.O. to take the competition tests. On the website of the U.O., the following are announced: the day, time and place of the competition tests.
- (2) The competition committee evaluates the candidate from the perspective of the following criteria:
  - a) the relevance and impact of the candidate's scientific results, in relation to the field of disciplines of the position for which the candidate is applying;
  - b) the candidate's ability to guide students or young researchers;
  - c) didactic skills of the candidate, in the case of didactic positions;
  - d) the candidate's ability to transfer his/her knowledge and results to the economic or social environment or to disseminate his own scientific results;
  - e) the candidate's ability to work in a team and the efficiency of his/her scientific collaborations, depending on the specifics of the candidate's field;
  - f) the candidate's ability to lead research and development projects;
  - g) the professional experience of the candidate in institutions other than U.O..
- (3) In the situation where the position in question is that of professor assistant/university lecturer, the competition committee has the obligation to check and ascertain, from the point of view of didactic and scientific relevance, the compliance with the standards for the occupation of didactic positions, specific the position, approved by the University Senate, according to the law.
- (4) In the situation where the position in question is that of associate professor/university professor, the competition committee has the obligation to check and ascertain the compliance with the minimum standards and the additional requirements from the point of view of didactic and scientific relevance. The minimum standards and additional requirements cannot deviate from the minimum national standards approved according to art. 156 paragraph (1) letter a) from the Higher Education Law no. 199/2023, with subsequent amendments and additions.
- (5) In the situation where the targeted position is research, the competition commission has the obligation to check and ascertain the fulfillment by the candidate of the minimum national standards



for conferring professional research-development degrees approved according to art. 156 paragraph

- (2) from the Higher Education Law no. 199/2023, with subsequent amendments and additions.
- (6) The criteria provided for in paragraph (2) are evaluated on the basis of the competition file and, as the case may be, additionally through one or more competition tests, which may include, according to the provisions of the faculty's own procedure: lectures, delivering a course, seminar, etc.
- (7) For professor assistant position, the competition will include a written test and/or a practical test (seminar, laboratory, project or other field-specific). The topic of the practical test is established by the president of the competition committee, with the consultation of its members, and is announced at least 3 working days before the test on the competition webpage, together with the day, time and place of the competition, thus inviting all candidates to take part in the competition tests.
- (8) For the positions of lecturer, associate professor and university professor, at least one competition test is represented by a didactic lecture. This test must also contain a session of questions addressed by the committee. The topic of the didactic lecture is established by the president of the competition committee, with the consultation of its members, and is announced at least 3 working days before the test on the competition website, together with the day, time and place of the competition, thus inviting all candidates to take part in the competition tests.

#### II.4. Competition commission: formation, attributions

#### Art. 17.

- (1) Establishing the structure of the competition committee, for each tendered position, is carried out after the publication of the announcement of the tendered position in the Official Gazette of Romania, Part III.
- (2) The competition commission is made up of 5 members, including its president, specialists in the field of disciplines of the tendered position or in related fields.
- (3) At least 2 substitute members are included in the structure of the competition committee (one of which is from outside the U.O., for the positions of professor or associate professor). In case of the unavailability of a member to participate in the commission, the respective member is replaced by the substitute member, appointed according to the same procedure as the members of the commission.
- (4) The council of the department or of the doctoral school in whose structure the position is found makes proposals for the nominal structure of the competition committee.
- (5) Based on the proposal mentioned in paragraph (4), the dean requests the opinion of the faculty council regarding the nominal structure of the competition committee.
- (6) The nominal structure of the competition committee, accompanied by the opinion of the faculty council, is sent to the university senate for approval. Following approval by the university senate, the competition committee is appointed by decision of the rector.
- (7) Within two working days of issuing the rector's decision, the decision is sent to the Ministry of Education, and the nominal structure of the competition committee is published on the competition webpage. In the case of the positions of associate professor, professor, scientific researcher II and scientific researcher I, U.O. will publish the list of the competition committee in the Official Gazette of Romania, Part III.



#### Art. 18.

- (1) The decisions of the competition commission are taken by the open vote of the members. A decision of the commission is valid if it meets the vote of at least 3 members of the commission.
- (2) The activity of the competition commission is led by the president of the commission.
- (3) The commission members can be from inside or outside the UO, from the country or abroad.
- (4) To fill in a position of associate professor, professor, scientific researcher I or scientific researcher II, at least 3 members of the commission must be from outside the UO, from the country or from abroad.
- (5) The members of the competition committee must have a higher teaching or research title or at least equal to that of the teaching/research position corresponding to the tendered position or, for members from abroad, meet the minimum standards corresponding to the teaching/research position of research related to the tendered position.
- (6) For the exclusive purpose of participating in the competition committee, the didactic or research titles of the members from abroad will be equated with the didactic or research titles from the country, on the basis of which the university senate approves the nominal composition of the competition committee.
- (7) The president of the competition committee can be:
  - a) the head of the department or the head of the doctoral school in which the open position is found;
  - b) the dean or vice-dean of the faculty in which the position is found;
  - c) a tenured teaching staff in the U.O., specialist in the field of the job's disciplines or in a related field, delegated for this purpose by the vote of the department council, respectively of the faculty council that organizes the competition.
- (8) When appointing the president of the competition commission, an alternate president will also be appointed (who will also be able to perform the function of substitute member of the competition commission).

#### **II.5.** Competition results

#### Art. 19.

- (1) Following the completion of the evaluation process, the competition committee establishes, for each position, the hierarchy of candidates and nominates the candidate who obtained the best results.
- (2) The president of the competition committee draws up a report on the competition (Annex 5), based on the evaluation reports (Annex 4) drawn up by each member of the competition committee and respecting the hierarchy of candidates decided by the committee.
- (3) The report on the competition is assumed by the signature of each member of the competition committee.
- (4) The result of the contest is published on the web page of the contest, within 2 working days from the end of the contest.
- (5) Competition files, including the report on the competition and the evaluation reports of the committee members, are submitted to the dean of the faculty, who organizes their discussion by the faculty council. In order to validate the competition, the presence of at least two thirds of the members of the faculty council is required.



- (6) The faculty council analyzes compliance with the procedures and gives its opinion or not to the report on the competition from this perspective. Any vote against or abstention will have to be justified and has the right of veto in case of proof of violation of the legal procedures in force. The hierarchy of candidates established by the competition committee cannot be changed by the faculty council.
- (7) Based on the decision of the faculty council, an excerpt from the minutes of its meeting is drawn up, to which a copy of the meeting convening list (with the signatures of all those present) is attached. These documents are added to each candidate's file.
- (8) The University Senate analyzes compliance with the procedures established by the U.O.'s own methodology and by the faculties' own procedures and approves or rejects the report on the competition. The hierarchy of candidates established by the competition committee cannot be changed by the university senate.

#### II.6. Appeal commission: formation, attributions

#### Art. 20.

- (1) In the event that a candidate has elements that can demonstrate non-compliance with the evaluation procedure based on the criteria provided for in art. 16 paragraph (2) from the present methodology and/or non-compliance with the procedures regarding the organization and conduct of the competition, the candidate can file an appeal within 3 working days from the communication of the result.
- (2) The appeal is formulated in writing, registered at the U.O. registry and submitted to the appeal commission for resolution.
- (3) The appeal committee analyzes the issues reported by the candidate through the appeal, which it resolves within maximum 2 working days from its registration and with regard to which it completes the report on the contest (Annex 5). The solution is announced no later than 2 working days after the submission of the appeal, on the webpage of the competition.
- (4) The appeal resolution commissions are established at the same time and following the same procedure as when establishing the list of the competition commission.
- (5) The members of the competition commission cannot be part of the appeal resolution committee.
- (6) Following approval by the university senate, the appeal resolution committee is appointed by decision of the rector.

#### II.7. Appointment to the position

#### Art. 21.

- (1) Following the approval of the result of the competition by the university senate, the rector issues a decision for the appointment to the position and the awarding of the related university title for the winning candidate. Appointment to the position is made starting with the semester following the one in which the competition was held.
- (2) Decisions on the appointment to the position and the awarding of the related university title for the winning candidates, accompanied by a synthetic report on the organization and conduct of the competitions within the U.O., are transmitted, within 5 days of issuance, in electronic format/on electronic media, with forwarding address to the National Commission for Attestation of University



Titles, Diplomas and Certificates (CNATDCU), through the specialized department within the Ministry of Education.

### II.8. Organizing and conducting the competitions for occupying vacant research positions in higher education institutions

#### Art. 22.

- (1) By way of exception to the provisions of art. 15 paragraph (1) and of art. 17 para. (2) from this methodology, the provisions of Law no. 319/2003, with subsequent additions.
- (2) In order to conduct competitions for research positions within the U.O., the attributions provided by Law no. 319/2003, with subsequent additions, are fulfilled as follows:
  - a) those provided for the scientific council of the institution, by the faculty council;
  - b) those provided for the institution's administrative board, by the university senate;
  - c) those provided for the scientific secretary or scientific director of the unit, by the head of the department, the head of the doctoral school, dean or vice-dean, according to their own methodology.

#### III. FINAL AND TRANSITIONAL PROVISIONS

**Art. 23.** If the tendered position has not been filled, the competition can be resumed, with full compliance with the competition procedure, in the next semester or academic year, as the case may be.

#### Art. 24.

- (1) The result of the competition is published on the website of the U.O., within two working days from the end of the contest. The result of the competition is also uploaded on the electronic platform managed by the Ministry of Education.
- (2) U.O. prepares annually, by September 1 at the latest, a synthetic report, in electronic format, regarding the organization, conduct and completion of competitions for teaching and research positions. The report is sent, for notification to CNATDCU, through the specialized department of the Ministry of Education.

#### Art. 25.

- (1) The heads of the departments, the deans of the faculties and the rector are responsible to the university senate for the smooth conduct of the competitions for the occupation of teaching and research positions, in compliance with the norms of quality, university ethics and deontology and the legislation in force.
- (2) If irregularities are found, the university senate can apply sanctions specified in its own regulations, including the dismissal of the heads of department and deans, upon the justified proposal of the board of directors or the rector or ex officio, with their opinion.
- (3) In the case of non-compliance with the legal provisions in the procedure for filling teaching and research positions, the Ministry of Education can apply the sanctions provided by law, based on a report drawn up by CNATDCU.
- (4) If the courts find a violation of the competition procedures for the teaching and research positions in the UO, the competition is canceled and restarted.



#### Art. 26.

- (1) Admission to a teaching position is conditioned by the presentation of a medical certificate issued on a specific form, adopted by joint order of the Ministry of Education and the Ministry of Health. The permits required for exercising the profession are established by the joint order of the Minister of Education and the Minister of Health, which is published in the Official Gazette of Romania, Part I.
- (2) Maintaining a teaching position is conditioned by a periodic medical check-up. The periodicity and granting of permits for the exercise of the profession are regulated by the order provided for in paragraph. (1), and the necessary funds for these controls are provided from the state budget.
- (3) Teaching staff who consider themselves aggrieved can request an expert assessment of their work capacity in the field of education.
- (4) In situations of professional incapacity of a psycho-behavioral nature of the employed staff, UO may request, upon notification of any factor involved in the educational process, by decision of the Board of Administration, a new complete medical examination.
- (5) Situations of professional incapacity of a psycho-behavioral nature are analyzed and determined by a committee consisting of 3-5 members, medical specialists, established at the level of the university center based on a protocol concluded between the Ministry of Education and the Ministry of Health, which carries out the expertise of the ability to work in the field of education.
- (6) Refusal of the teaching staff to attend the medical examination constitutes a disciplinary offense and may lead to the termination of the individual employment contract.

#### Art. 27.

(1) The present methodology enters into force starting with the second semester of the academic year 2023-2024.
